ILLARIA STEELE, TWELVE YEARS OF SERVICE AS A CALN COMMISSIONER

As of December 31st of this year, Mrs. Illaria Steele will be completing her twelfth year as a commissioner in Caln Township. Elected in November of 1993, Mrs. Steele was one of two female Commissioners elected that year. They were the first women ever elected as Commissioners in Caln Township. Why did she decide to place her hat in this political ring. Illaria says that so many residents had urged her to run. They felt they needed a voice in the Township which she could provide. This request certainly was valid, for she was re-elected to two additional four year terms after the initial term. What are some of the accomplishments of which she can be proud. Early on she discovered that the war memorial monument in Caln Park was basically hidden, misused and generally unknown. This was a desecration of a part of history.

Mrs. Steele had the memorial re-located to a more appropriate place of honor at the entrance to Caln Park. Other accomplishments during her tenure include the building of the new train station and the promotion of the sidewalk concept throughout the Township. She was especially responsible for the sidewalk along G.O. Carlson Boulevard. Prior to that time, residents had to walk in the road or by the curb. Another proud accomplishment has been the renovation of the Giant shopping center and other businesses.

TOM HINKLE, EIGHT YEARS OF SERVICE AS A CALN COMMISSIONER

In the mid 1980's a Commissioner's seed was planted in the mind of Tom Hinkle. This seed was nurtured during his years as a Republican Committee Person. Finally, in 1997 this seed germinated into full bloom when Tom was elected by the people of Caln Township as a Commissioner. During the early years Tom worked as an Engineer with PECO, being assigned to the nuclear power plants at Peach Bottom, Limerick, Oyster Creek and Three Mile Island. In addition he was active as a guest speaker at many of the American Society of Mechanical Engineers meetings across the United States. This engineering experience plus his managerial experience were both brought to Caln Township when Tom was elected. Some accomplishments which Tom noted have occurred during his tenure include the reorganization and strengthening of most every Township Department.

We now have a full time Engineering Department, an expanded Codes Department, a newly formed Wastewater department, a full time Parks and Recreation Superintendent plus a more streamlined and computerized Finance Department. Tom has been liaison to the Codes and Engineering, Finance, Roads, Police and Fire Departments at various times during these past eight years. The reorganization and strengthening of these departments were necessary to meet the growth and demands placed on our Township due to the constantly expanding residential and commercial activity. He was instrumental in developing a

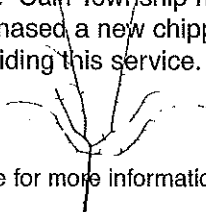

While taking her grandchildren to Caln Park, Illaria became increasingly interested in renovating our entire park system. In this regard she has been the Commissioner liaison to the Parks and Recreation Committee these past seven years. Early on in her tenure, Caln Park underwent a \$400,000 renovation, partially funded by the state and county. Dawkins Park had new play equipment, a water fountain and a new pavilion installed. Of course, the Griffith Farm including 130 acres was purchased during Mrs. Steele's tenure. This will eventually be developed as a recreation area for all Caln residents in the near future. An annual Christmas Tree Lighting Ceremony, the restoration of Caln Pride Day, an annual Halloween Parade and Easter Egg Hunt, and now, more recently, the public concerts and movies have all been a part of Illaria's legacy to our Township.

In closing, Mrs. Steele wants to thank all those who supported her over the years. She states that she has learned so much during this time, especially all it takes to "run" a township. "It is more than I could have ever learned in college", she says. King Charles II of England declared that these Spaniels were the only dogs permitted in the House of Parliament. When Tom was first seeking election as a Commissioner he campaigned on three main items: To work for orderly growth and smart management of our Township. To help keep Caln Township a safe and friendly place in which to live and work. Work to promote new business while preserving the existing businesses. It is obvious from the above noted accomplishments that he has kept these promises.

Finally, Tom states that he is proud of the way his fellow Commissioners have worked together for the benefit of our Township. He says that so often there is such conflict among Township leadership that it is detrimental to the citizenry they are elected to serve. 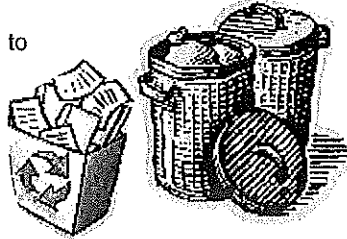

CALN TOWNSHIP TRASH AND RECYCLING PROGRAM

An important service to our residents is the weekly collection of trash and recycling.

In regard to trash, users may place up to six containers of trash for pickup each week. Recycling of glass, aluminum cans and plastics should be put out at the same time in a recycling bin provided by the Township. Newsprint should be placed inside a brown paper bag and stacked with the recycling. One bulk item may also be placed at the curb each week. Every January, Christmas Trees may be placed at the curb for pickup by the trash hauler.



For many years Caln Township had collected trash and recycling and paid for that service directly from the Township's General Fund. Two years ago a new contract was awarded that includes a twenty-six percent increase in costs from the hauler. In addition, the tipping fee charges paid by the Township at the landfill had increased significantly, due in part to a state imposed tax increase on every ton of trash disposed. When contacted about the additional cost of this fee to municipalities, state officials advised the township to "pass it on to the customers." The overall cost of trash had become too great to continue without the institution of a fee. Virtually all of our neighboring communities have trash fees that average three times or more of the amount of the Caln Township fee. The Township established a Solid Waste Fund in 2003 to be used for the trash collection costs. All fees are deposited directly into that fund. The present \$50 fee covers about one third of the total cost for trash collection. The other two thirds are still paid for by the Township's General Fund. A new trash contract will be bid this winter for 2006 through 2008.

In addition to trash and recycling collection, the Township picks up leaves each fall and has recently begun the new chipping program mentioned elsewhere in this newsletter. For more information please contact Cheryl Lafferty at 610-384-0600 ext. 3.

A household generates between one and 1.5 tons of trash per year

Attention!! Public Sewer Customers

Sump Pump Amnesty Program
Expires September 30

It is illegal to have your sump pump hooked up to the sanitary sewer system. In order to address the illegally connected floor drains, downspouts, and sump pumps, the Township has offered residents the opportunity to participate in the Sump Pump Amnesty Program. The Amnesty period expires on September 30, 2005. Property owners are asked to inspect their own plumbing, in order to identify illegal hookups and to remove any illegal connections to the public sewer system. Owners who do not have the expertise to determine if their sump pumps, floor drains and down spouts are illegally connected should call the Township at 610-384-0600 x 139 for assistance, and more information on the program.

Property owners should be aware that after the Amnesty program expires, homes with these types of illegal connections detected through other means (i.e. dye testing, U & O inspection, camera inspection) may ultimately be cited for being in violation of Resolution 2005-1-CTMA subsection 12A which prohibits discharge of "any storm water, surface water, ground water, water from sump pumps or floor drains, roof runoff, subsurface drainage, cooling water or unpolluted industrial process waters." Penalties may be incurred as noted in Resolution 2005-1-CTMA subsection 35 which states, "violators may be punished by a fine of not less than \$100 and not more than \$1000 for each offense plus costs and attorney fees. Each separate billing building, each separate dwelling and each separate discharge in respect to which a violation occurs shall be deemed a separate offense."

MUNICIPAL AUTHORITY ACCEPTS TRANSFER OF SEWER SYSTEM

On June 30, 2005 the Board of Commissioners approved the Deed of Dedication for the transfer of the sewer system to the Caln Township Municipal Authority.

On July 25, 2005 the Caln Township Municipal Authority Board accepted this Deed of Dedication. The Municipal Authority is charged with the operation and maintenance of the sanitary sewer system.

COOKING GREASE IS THE NO. 1 CAUSE OF SEWER BACKUPS IN HOMES.

What problems are caused by grease?

- Clogged drains or toilets.
- Sewage backups into your home.
- Sewer overflows in neighborhood parks, yards, and streets.
- Rancid odors.
- Expensive cleanup, repair, and replacement of damaged property.
- Potential contact with bacteria and viruses that can cause illness.
- Higher operating and maintenance costs, potentially resulting in higher sewer bills for you.

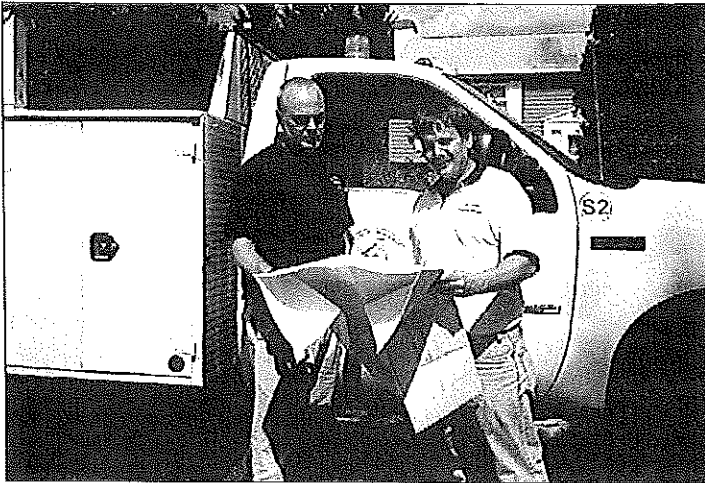
Why is cooking grease a problem?

If you pour cooking grease down your drains, it may build up, block your pipes, and cause rancid odors, or messy costly sewage backups in your home. It can also clog the Township's sewer lines. When you pour hot grease down your drains, the grease eventually cools, then congeals and coats pipes. When enough grease builds up, it can block your plumbing or the Townships sewer lines.

DON'T POUR COOKING GREASE DOWN DRAINS

How can you help protect your plumbing and our environment?

- Never pour grease down sinks, toilets, or any drains.
- Pour grease into a can for disposal in the trash. You can make your own grease can using any empty metal can (not plastic, which melts) and disposable, heat-resistant oven bags. Just toss the bags in the trash (after grease cools) and reuse the can. (Note: Please use caution when pouring hot grease or wait for it to cool slightly.)
- Hot grease can burn skin.)
- After grease cools, scrape grease and food scraps into a can or the trash for disposal.
- Use strainers in sinks to catch food scraps, and empty the strainers into the trash.
- Don't rely on a garbage disposal to get rid of grease—it grinds food into smaller pieces, but it doesn't keep grease from going down the drain.
- Wipe cookware and dishes before washing. Commercial additives in detergents only dissolve grease temporarily.
- Talk with your friends and neighbors about the grease problem, so that the community is aware of the risk.

NEW SEWERS FOR PARKSIDE GO OUT TO BID

At a public meeting on July 14, 2005 the Board of Commissioners authorized the bidding of a new sewer line to serve the Parkside Neighborhood. Using a \$154,000 HUD grant, the project will install public sewers within the neighborhood that is presently served with on-lot systems. Poor soils and small lots have caused problems for on-lot systems within this area in the past. Construction is expected to be completed in the fall.

PERMITS

WE RECEIVE MANY QUESTIONS REGARDING OUR BUILDING AND ZONING PERMITS.

Here is some general information on how to secure a permit.

First of all, if you are having a contractor perform the work on your project, he must be registered in Cain Township and have insurance. This is for your protection.

It can take up to 30 days to have your application for a permit reviewed; however, if you follow the building protocol step by step the process normally takes less time. It is very important that you provide a plot plan that shows us **EVERYTHING ON YOUR PROPERTY** (house, garage, shed, deck, patio, pool, driveway, etc.) and the dimensions of each of those items. Setback dimensions from the property lines are also required. If building an addition, deck, roof, porch or altering a structure, we must receive proper construction documents with your application to allow a building review to be completed in accordance with the 2003 International Building Codes.

Submitting an application without the required information will delay the process.

Emergency Response Team

The Western Chester County Emergency Response Team is a cooperative effort between several surrounding municipalities. This Team specializes in providing a strategic response to those situations above and beyond the capabilities of ordinary patrol duties. Officers selected for this duty come from the patrol and detective units of their home departments. All members of the Team are volunteers.

Officers from the Caln Township Police and the Coatesville City Police Departments formed the Team in 1997. The Team continued to expand over the next few years to include officers from West Brandywine Township, Brandywine Regional, Downingtown Borough, Parkesburg Borough and East Fallowfield Township Police Departments. The Team currently includes over 20 sworn officers.

The Western Chester County Emergency Response Team responds to barricaded subjects, hostage situations, high risk warrant services and protection details. The Team's mission is to bring a tactical solution to an incident that is extremely dangerous or potentially violent.

Most incidents involving an emergency response team have a much higher chance of a peaceful outcome. This is due to their specialized training. With specialized tactics, weapons and equipment many more options are available than would be available for the officer on patrol.

Our Team trains at least monthly in firearms, tactics and physical conditioning. Training is also conducted in mock scenarios using roll players. Cross training is done with crisis negotiators that are also part of the Team.

Identity Theft

There is a crime-wave sweeping the nation. You could be a victim and not even know it yet. It's an easy crime to commit--the payoff is usually significant and apprehension of the criminal by police or enforcement agencies can be very difficult, many times impossible. It's called Identity Theft.

Identity theft occurs when the "thief" uses your name, date of birth, address, social security number or virtually any other type of identifying information to commit crimes against your credit. The thieves are able to assume control of your existing assets, such as bank accounts and in many cases will open new accounts or obtain loans using your information. Many times the victim is unaware of the frauds that have been committed against his/her credit until they are applying for a loan themselves.

The Caln Police Department has handled an increasing number of these complaints over the past several years.

Although we will diligently pursue your complaint to the best of our ability, prevention is the key with this crime. Here are a few tips to remember:

-Dispose of items containing your personal information. Use a SHREDDER (preferably a cross-shredder). Shred documents containing social security numbers, account numbers, pre-approved loan/credit

card offers, etc.

-Secure any personal information in your home in a locked safe--remember to secure the safe so that it cannot be removed from the home, as well.

-Never provide personal information over the phone, through the Internet, or through the mail unless you initiated the contact and know with whom you are dealing.

-Only carry the credit cards that you will be using. Secure other cards at home or cancel unnecessary accounts. Instead of signing your credit card, write "See ID" or "Ask for ID" on the back. Report any lost or stolen cards immediately.

-ID Thieves steal mail. Pick up your mail promptly from your mailbox and guard your outgoing mail from theft by dropping off directly at the Post Office and not placing in your unsecured mailbox.

-Memorize unique passwords/PIN numbers. AVOID using your name, date of birth, or the last four digits of your SSN.

-Order a copy of your credit report from credit reporting agencies annually. Check the information contained within. (There may be a fee for credit reports).

FROM THIS TO THAT

In recent years, the look and feel of Caln Township has changed. To some, this is welcomed; to others, it is unnoticed. But to all, inevitably the Township is changing almost daily. New businesses pop up such as Commerce Bank, Kohl's, and Advanced Auto. Some existing businesses do major renovations such as Brian Hoskins Ford, Giant, and the Thorndale Shopping Center. New subdivisions appear such as Woods at Edge's Mill, Bailey Station, King's Grant, and Woods at Rock Raymond.

Some may wonder how all of this happens. How does an individual or a company build these new projects? What rules and regulations do they follow? Who is making sure all of this development is done in accordance with these rules and regulations? To the lay person, it seems as though the "THIS TO THAT" process just happens. However, the Township has a very systematic process that all must follow to ensure that the safety and welfare of the Township residents and customers is maintained.

The first step in going from THIS TO THAT is to formally apply to the Township with an application stating the intentions for the property. Township Staff reviews this application, looking at such issues as zoning, storm water, traffic, infrastructure, sewer, and the degree of consistency with the Township's Comprehensive Plan (available at www.caintownship.org). Staff offers their comments to the Township's Planning Commission for their consideration. The Planning Commission, consisting of six individuals, discusses the intention of the application and Staff's review, and then offers their recommendation to approve or deny the application to the Board of Commissioners.

By the time the application gets to the Board of Commissioners for their action, all of the details of the plan (i.e. storm water, traffic, sewer, etc.) have been worked out as best they can be. If the Board acts on the application favorably, the applicant must then submit building permits to ensure they comply with the newly adopted and administered State-wide Building Code. The building permit application is reviewed to verify compliance with the building code, and if in compliance, a building permit is issued.

At this stage, construction is ready to proceed. Township staff and their professional consultants continually monitor the construction activities to ensure all of the rules and regulations are being followed. Once the project is completed, a final inspection is performed and a Use and Occupancy Permit is issued and what was once a "THIS" is now officially a "THAT".

Traffic Signal Closed Loop System: This is a multi-municipal project including Caln Township, Downingtown Borough, and the City of Coatesville. Caln Township has nearly \$1M dollars in federal funding to upgrade all of our traffic signals and to connect the signals together. This will allow for better traffic congestion management once implemented. It is anticipated implementation will occur in 2006.

Lincoln Highway Streetscapes: This is a sidewalks and streetscapes project that is federally funded in the amount of \$525,000. This project will install sidewalks, street trees, and street lights on Lincoln Highway from Route 340 to Municipal Drive. It is anticipated that construction will occur in 2006.

Carver Court Streetscapes: This is a sidewalk project for the Carver Court neighborhood. The Township is completing this work with a grant from Chester County in the amount of \$411,970.00. This project is near completion.

North Bailey Road Bridge: This is a local bridge replacement project which requires replacing the bridge on North Bailey Road at the Township border with East Brandywine Township. The construction of this bridge will be paid for with Federal monies, and it is anticipated that construction will occur later this year or early 2006.

340 Corridor Traffic Patterns: Initial discussions with PennDOT have been held regarding the reconfiguration of the turn lanes, lane width, and traffic signals from the GO Carlson/Route 340 intersection to the Lincoln Highway/Route 340 intersection. This project is intended to relieve some of the traffic congestion at these intersections, and is anticipated to commence no sooner than 2006.

The Woods at Rock Raymond Road

As you pass by the Route 322 exit of the Route 30 Bypass going west, look to the right; you will see more new construction in Caln Township. These upscale townhomes



are an extension of the age restricted 55 and over community adjacent to the Downing Forge Development. Many of these townhomes have first floor bedrooms, and either one or two car garages. When the development is completed, there will be a total of 122 townhomes constructed.

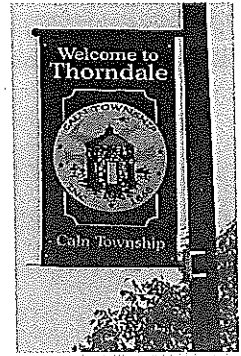

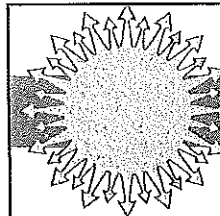

Caln Township Townwatch - Volunteers Needed

The mission of the Caln Township Townwatch Organization is to help discourage unlawful activity in our neighborhoods. We work as a volunteer organization, under the supervision of the Caln Township Police Department led by Chief John Bennett. We meet monthly and patrol our neighborhoods regularly.

Townwatch volunteers never become involved directly in any law enforcement activity. Our task is to observe and report any illicit activity to the Police Department. Our volunteers receive simple guidelines for patrols including training in techniques of observation while on patrol, and how to operate a CB (Citizen's Band) radio. We also have the ability to patrol using two-way communications via Nextel radio-telephone. We have never experienced an incident where a volunteer was placed in a hazardous situation or open to personal risk.

During 2004, Townwatch volunteers actively patrolled neighborhood streets on a regular basis as well as on special occasions, such as Mischief Night and Halloween nights. Last Mischief Night, our patrols reported 4 separate incidents which were investigated by the Police Department.

In addition to patrols, Townwatch members also volunteered 139 hours of their time in 2004 to serve the community in other ways-such as fingerprinting children at various community events.

We are looking for new members to provide additional patrols and increased community involvement. Your participation would involve only a minimum of 3 hours per month. 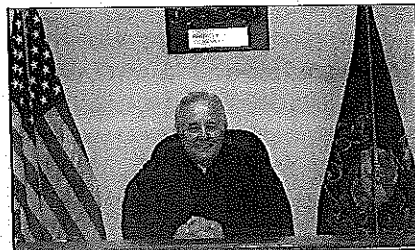
JUDGE JIM CHARLEY

All Rise, Please

Here you see Magisterial Court #15-4-02 located in the Valley Run Shopping area adjacent to the North Bailey Road. It is the busiest Magisterial Court in Chester County. This court, presided over by Magisterial Judge Jim Charley serves both East Brandywine and Caln Townships. All criminal cases start at this level. This includes any violation of the criminal code such as homicide, rape, arson, etc. Arraignment with bail is set. Then a preliminary hearing is held to determine whether or not there is enough evidence to send the case to Common Pleas Court for trial. In addition to criminal cases, Judge Charley also presides over violations of the Motor Vehicle Code including speeding and stop sign violations. Disorderly conduct cases and harassment come under his jurisdiction as well. Zoning Code violations and licensing as well as Civil Suits up to an amount of \$8,000 are also held in Judge Charley's court.

The knowledge of all laws of the state of Pennsylvania or the ability to access the laws is required. This is included in the training requiring basic certification. Every year a one week up date training session is required so that Judge Charley is aware of new laws, policies, and most recent court precedents.

Editor's note: Don't go over 25 miles per hour in your automobile, be kind to your neighbor, pay your bills on time, pick up after your dog on G.O. Carlson Boulevard, and cut your grass before the weeds go to seed. Let's all help reduce the cases in the Thorndale District Court.

Although we have been experiencing the heat of summer, it will soon be that time of year when cooler winds blow and leaves begin to fall from the trees. Yes, the multiple colors are beautiful to see, however, it also will begin the arduous process of raking, bagging, cleaning out flower beds, etc.

Leaf bags are available for purchase at the Caln Township building. Bags come in bundles of 5 for \$1.50 but can also be purchased individually at \$.30 each. Besides leaf bags, Caln Township has just purchased a leaf vacuum. As an alternative you may now rake your leaves to the front of your property at the road's edge on two selected times this fall. DO NOT rake leaves into the street.

Without an appointment, the road crew will not pick up.

Designed to aid Caln Township residents with downed tree limbs, it is a free service and may be used once during the fall program period by Township residents.

The Public Works Department will be out on Wednesdays and Thursdays each week, weather permitting. **Residents wishing to utilize this program need to call before November 1, 2005 for an appointment to be added to the schedule.** Please do not make the assumption that because your neighbor has items out it is okay to just put yours out as well.

Please call 610-384-0600, x4. Below are additional guidelines to be followed:

All branches and limbs must be stacked at the front of the property next to the street (where trash cans are placed for pickup).

Note: Due to liability concerns, the road crews will not drive onto property or private lanes/roadways, nor will road crews go beyond the edge of the property to collect the limbs.

- All branches should face the same direction (no cross-stacking) with the widest part of the branch/tree limb facing the street
- No stumps or limbs greater than 8" in diameter
- A resident may use this service one time during the fall time period
- No vines, weeds, or yard waste will be collected
- The program is for routine cleanup and not designed to assist with clearing properties of trees and shrubs (i.e. cutting trees down and putting out for chipping).

This program is for individual Caln Township residential properties only. Items collected from outside the Township or through a private or commercial operation *will not* be processed.
