The Township collects an annual trash and recycling fee from each home. The fees collected cover the cost of our waste hauler, landfill costs, recycling disposal, leaf collection, yard waste collection, the chipping program, and weekly bulk item collection. The annual cost of trash and recycling collection is \$354 per household, divided into 6 bi-monthly payments.

If your property is connected to public sewer facilities you are subject to pay for the operation of the utility. Caln Township provides sewer service at an annual rental rate of \$492 per home. Note that the connection of sump pumps and downspouts to your sewer line is strictly prohibited (these increase our sewer treatment costs substantially).

Townships, counties and school districts levy taxes on real estate in the form of mills. A mill is \$1 of taxes for every \$1000 of a property's assessment. The average home in Caln Township is assessed at \$150,000. One mill of tax, costs the average homeowner \$150.00 and at the current total tax rate of 5.128 mills (Property, Fire and Debt Taxes), the average tax to the homeowner amounts to \$769.20 this year.

The Township assesses properties within several streetlight districts for the streetlight tax.

Assessments are based upon the cost of the service and the front footage of the property. The Street Light Fee is assessed by property location, not all residents will receive this bill.

- \* All taxes and fees are the responsibility of the property owner and mailings will be forwarded to the owner address, this includes rental and leased properties.(72 P.S. § 5511.7)
- \* An Earned Income tax and Local Service tax are collected by Keystone Collection Services on behalf of the township. Keystone can be reached at 724-978-0300.
