AN ORDINANCE OF THE CALN TOWNSHIP BOARD OF COMMISSIONERS AMENDING CALN TOWNSHIP'S CODE OF ORDINANCES, PART I ADMINISTRATIVE LEGISLATION, CHAPTER 48 TAX COLLECTOR, ARTICLE II COMPENSATION, SECTION 48.3 COMPENSATION OF TAX COLLECTOR

WHEREAS, The Commissioners of Caln Township have the right and duty to assign compensation for the position of Tax Collector as defined by Section 801-A(b) of the First-Class Township Code, and

WHEREAS, the following changes shall be amended by act of this Ordinance to the existing Code, Specifically Part I of Administrative Legislation, Chapter 48, Article II, Section 48.3

The compensation for the Tax Collector for Caln Township for the four-year period beginning January 1, 2022 shall be \$500 per annum. Said rate shall continue for subsequent terms until amended by ordinance of the Board of Commissioners.

NOW, THEREFORE LET IT BE ORDAINED THAT THE CALN TOWNSHIP BOARD OF COMMISSIONERS AMENDS THE CALN TOWNSHIP CODE OF ORDINANCES, PART I ADMINISTRATIVE LEGISLATION, CHAPTER 48 TAX COLLECTOR, ARTICLE II COMPENSATION, SECTION 48.3 COMPENSATION OF TAX COLLECTOR
