Chico's Vibe will be back by popular demand and the fireworks will begin around 9.


On August 16, once the sun goes down, we'll sit under the stars and enjoy a movie in the park. Movies kick off around 8:30PM.

- Chester County School Authority Horticultural building – conditional approval granted by Board of Commissioners, working through outstanding items
- Christian Faith Fellowship - preliminary/final plan resubmission in review
- Hills at Thorndale Woods - final PRD plan resubmission in review
- Wild Meadows - demo permit request for 18 month extension granted, updated zoning text amendment submitted, on PC agenda August 20
- 2131 Lincoln Highway - zoning text amendment submitted to allow for self-storage in the C-1 zone
