



If you'd like to vote by mail in the November election, the online mail-in ballot application is now available at votespa.com.

The last day to request a mail-in or civilian absentee ballot is October 27th, but we recommend getting your request in ASAP.

The last day for County Boards of Elections to receive mail-in and absentee ballots is November 2nd (must be received by 8:00 P.M.).

You must be registered to vote to request a mail-in or absentee ballot. To check your voter registration or to register to vote, visit votespa.com.

Chester County will be hosting a Household Hazardous Waste event on August 1st (Saturday) and 2nd (Sunday) in Caln Township. You MUST pre-register.

- No commercial waste
- No illegal materials
- No mixing - Do not mix materials.
- Tighten all lids - If containers are leaking, pack in a larger container with newspaper to soak up the leaks.
- Items must be identifiable - Bring all substances in original containers with labels.
- 25 gallon/220 pound limit

All HHW items must be in the trunk, cargo area of an SUV, or bed of a truck. HHW staff will remove all items. Do NOT leave your vehicle!

Stay in your vehicle. Masks must be worn.
This will be a "contact-less" event!

Only 1 Person per household per vehicle. New PADEP approvals limit capacity at these events. The event will be monitored to ensure compliance.

COVID-19 Impacts

- Township offices remain closed to the public at this time. Township employees will be available via phone and email to help maintain our usual level of service as much as possible.
- The Board of Commissioners has extended the property tax face rate amount until August 31, 2020.

- Trash Collection - On Schedule - All trash must be bagged and tied. All bags must be placed inside your mobile cart. Loose items will not be collected.
- Recycle Collection - On Schedule - Please break down and bundle cardboard boxes.
- Yard Waste Collection - On Schedule
- Bulk Item Collection - On Schedule
- Township meetings will be held remotely via Zoom. You can see the calendar of upcoming meetings and links to attend on Calntownship.org. If you'd like to attend by phone or have any questions about participating, please email info@calntownship.org or call 610-384-0600 x148.
- Township parks are currently open.
- The dog park at Lloyd Park will be open with a limit of 25 people at one time. Please pick up after your dog and practice social distancing.
- Pavilions will be open, but you must maintain 6ft social distancing from people outside of your household. Picnic tables and grills will NOT be sanitized, so please bring your own sanitizing supplies and/or table cloths. Pavilions are first-come, first served – no reservations will be accepted at this time.
- Play equipment and sports courts are available for use but we are unable to guarantee that they will be sanitized, so please use with caution and at your own risk.
- Bathrooms and drinking fountains remain CLOSED at this time.

Updates from the Police Department

Congratulations to Corporal Kevin Bernard for reaching a milestone in his career. June 11, 2020 marked twenty five years of service with the Caln Township Police Department. In addition to his duties as a patrol supervisor, Corporal Bernard serves as the department's firearms and defensive tactics instructor, First Aid/CPR instructor, and he is also the Deputy Commander of the Chester County Regional Emergency Response Team (SWAT).



The Caln Township Police Department has designated a "Safe Zone" meeting area in the parking lot at the front entrance of the Police Department to conduct safe online transaction exchanges. For added safety, this area is equipped with a 24 hour live surveillance camera. Look for the green "Meet up Spot" sign near the front entrance of the Caln Township Police Department.

Caln Township's Police Department Chief Joseph Elias joined other panelists (Chester County District Attorney Deb Ryan, Coatesville PD Chief Jack Laufer, South Coatesville Borough PD Chief Kevin Pierce, Valley Township PD Chief Brian Newhall and Chester County Sheriff Fredda Maddox) on July 1st at New Life In Christ Fellowship for a well attended Community - Police Partnership Forum. We thank PA State Representative Dan K. Williams for hosting the program and District Judge Gregory Hines for serving as the moderator. We also thank the many community members that attended and participated in person and on Facebook.



Upcoming Development

- Willows at Valley Run (2131 Lincoln Hwy.) Seeking conditional use approval for a 120 unit apartment complex with community building. Scheduled for August 18 Planning Commission Meeting and conditional use hearing on August 27.
- The owners of Chester County Sports Arena have submitted a conditional use/land development application for recreational use. Scheduled to attend Planning Commission meeting on July 21 and conditional use hearing on August 13.
- 50 Rock Raymond Rd. (Taco Bell) Requesting modification of conditional use to add second drive-through lane. Scheduled for conditional use hearing on July 30th.
- Behrle/The Villages at Hillview was granted final land development approval pending conditions.
- Dwell – Final PRD approved at May 28th BoC meeting.
- AGC Chemical - Land development for building expansion approved.
- Dunkin Donuts at 1895 Lincoln Highway - Drive-through conditional use granted, waiting on land development plan.

Spotted Lanternfly Update

Spotted lanternflies (SLF) are back with a vengeance again this year throughout the township. Some reminders:

- SLF is a destructive invasive pest threatening agricultural and ornamental plants.
- As of May 2020, 26 counties in Pennsylvania are under quarantine for SLF. SLF has also been found in 5 other states in the northeastern U.S.
- SLF does not bite or sting.
- SLF does not kill all trees it feeds on. SLF is a plant stressor that, along with other stressors, can cause significant damage to its host.
- Stop the spread of SLF by checking your car and any outdoor equipment (grills, mowers, firewood, etc.) when going in and out of the quarantine zone.
- Manage SLF on your property by scraping and destroying eggs, carefully using bands or traps on trees, removing preferred hosts, and using registered insecticides for control when appropriate.
- Please be extra cautious when attempting to trap or poison lanternflies since this may cause harm to birds, bats, and beneficial insects.
