Caln Township Park Rules and Regulations

Violation of any of the following will result in the loss of your security deposit.

1. Park is open from dawn to dusk, without exception.

- 2. Possession or use of any controlled substances or alcoholic beverages is *strictly* prohibited.
- 3. Anyone desiring the use of the pavilion must first obtain a Park Use Permit. Applications for this permit are available at the Township Office Monday through Friday, 8:00 am-4:00 pm. Permit fees are established for Township residents: \$40.00 and for non-residents: \$80.00. This fee is non-refundable. Non-residents may be required to obtain sponsorship from a Township resident prior to being granted a park use permit. Other fees: \$100 refundable security deposit is collected. The security deposi includes the use of the Park restroom. Deposit will be retunred if pavilion area is retunred to proper condition.
- 4. Parking is permitted only in designated parking areas. No parking on grass.
- 5. Defacing or damanging any Township property is strictly prohibited.
- 6. Disorderly conduct, excessive noise, public intoxication, indecent language, loud music, or gambling is prohibited.
- 7. Permittee is responsible for returning the park to a clean condition. All refuse and recyclable material must be placed in the appropriate receptacles provided. Clean up work done by the Township will be subject to an additional fee, which will be the responsibility of the permittee. This fee will be based on the time required to return the facility to a satisfactory condition.
- 8. No dogs or other animals, either on or off a leash, shall be permitted in a Township park at any time, unless necessary for a physically challenged individual.
- 9. No go-carts, mini-bikes, off-road motorcycles, or similar vehicles shall be permitted on Township park property.
- 10. These Rules and Regulations are subject to change from time to time, at the direction of the Caln Township Board of Commissioners. A copy of the current Rules and Regulations shall be posted on the bulletin board at Municipal Park. Any persons using any park facility shall observe and adhere to all Park Rules and Regulations and any applicable Township Ordinances.
