

DEVELOPMENT Update

- 50 Rock Raymond Rd. (Taco Bell) - approved for development, finalizing legal agreements, request for extension of zoning variance approval, ZHB hearing scheduled September 5.
- Behrle/The Villages at Hillview - preliminary plan resubmission received and in review.
- 15 Fox Ave Townhouse - applicant received some variance approvals, with exception of density.
- Chester County School Authority Horticultural building – site work in progress, building plans approved.
- Christian Faith Fellowship - motion for approval of preliminary plan approval being prepared for the BOC.
- Hills at Thorndale Woods - final PRD plan resubmission in review
- Wild Meadows - PC made a recommendation for BOC to consider the applicant’s proposed zoning amendment with no commercial uses.
- 2131 Lincoln Highway - Chester County Planning Commission review received, now awaiting BOC decision to hear proposal.

Fall Chipping Program


