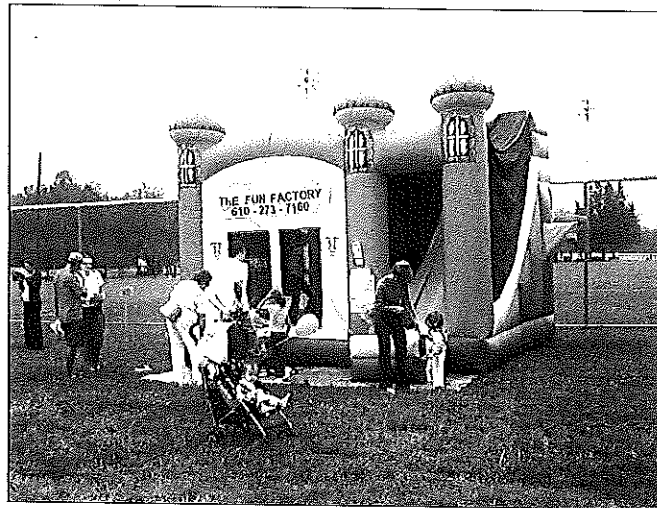

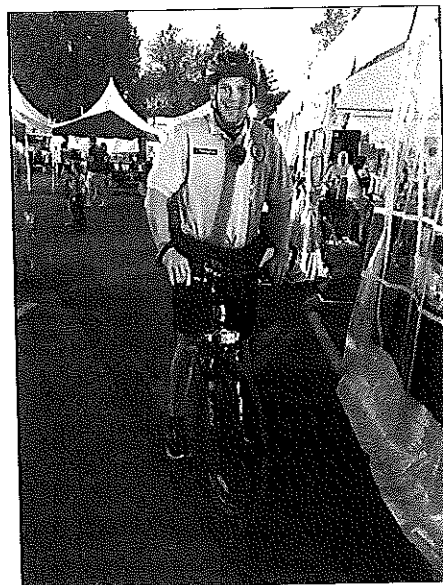

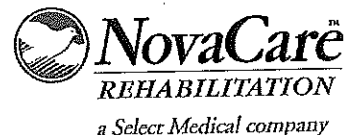

Township to Distribute Trash Carts to Residents

This fall the Caln Township Board of Commissioners will be distributing a trash cart to all solid waste collection customers. Similar to the recycling carts distributed several years ago, these new carts can only be used for trash, and are identified by a black lid which will distinguish this cart as trash only.

The standard cart sizes to be distributed will be 35 gallon or 65 gallon capacity carts. Those residents currently utilizing the 35 gallon capacity recycling cart will automatically receive a matching 35 gallon capacity trash cart. Your new trash cart will be required to be used as your primary container for trash collection. In addition to this, you will be able to set out two additional 35 gallon watertight trash containers or bags on each collection day.

The carts will be purchased primarily with funds from a recent PADEP grant reimbursement due to our past recycling activities. The carts will be assembled and distributed by the vendor to all properties in October-November.

Why are we distributing the carts? The carts are more secure than bags, keep out rain and vermin and will be easier to transport trash to the curb. In addition, the trash haulers are beginning to use automated trash trucks which are designed to pick up and dump the carts. This reduces labor costs and future Township contract costs. At some point in the future we expect to receive lower cost bids that will require the use of these style carts. This keeps costs down and reduces the need for the increase of trash fees.

What about existing trash containers? If you want to dispose of old trash containers, the Township will schedule one or more collection dates to collect old containers for proper recycling and disposal.

When placing your trash and recycling carts at the curb on your scheduled collection day, allow 3'-4' between carts and position with arrows facing towards the street to allow for proper pick up. Both the trash and recycling carts are registered to your property. If you move, the carts must remain for the next property owner.

It is violation of state law to place yard waste in your new trash cart because the contents end up in a landfill. Caln Township has started a pilot project to collect these materials. Please watch for notification(s) about requirements and restrictions pertaining to yard waste collection. In January of 2015, the Board will decide whether to continue yard waste collection in the future, so let us know what you think.

We cannot accept concrete, construction debris, dirt, etc. under any circumstances, so insist that your contractor disposes of construction refuse associated with property improvements.

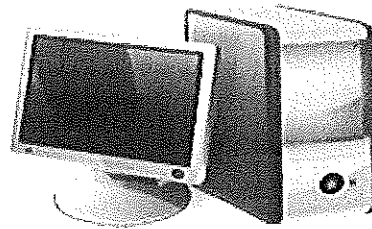

ACT 167 and Stormwater Management

ACT 167

Caln Township has required stormwater management since the late 1970's. In March 2003 the Township's Board of Commissioners passed a comprehensive storm water management ordinance revision that was aimed at, among other things, reducing erosion, reducing flooding, improving water quality, and protecting natural resources. With the adoption of the County-wide Act 167 Stormwater Management Plan, the Township was mandated to adopt a new stormwater management ordinance consistent with the County's plan.

In watersheds with approved PA Act 167 plans, any individuals or entities involved with altering the stormwater runoff characteristics from the land within the watershed are required to implement measures to manage the quantity, velocity and direction of stormwater runoff in a manner that adequately protects the health of the public and property from possible damage. On December 19, 2013, the Board of Commissioners adopted the new stormwater ordinance that complies with the Act 167 requirements. Something as small as a patio or a building addition may be required to have stormwater management installed as part of the project. Those property owners looking to perform construction work should consult with the Township Engineer, Mr. Jeffrey W. McClintock, PE, CFM, prior to finalizing said construction plans.

STORM WATER MANAGEMENT

The Township prohibits non-stormwater discharge to enter the municipal separate storm sewer system and the Waters of the Commonwealth. The following discharges are authorized unless they are determined by the Township to be significant contributors to pollution of the Township's separate storm sewer system or to the Waters of the Commonwealth: discharges from firefighting activities, potable water sources (including water line and hydrant flushing), irrigation drainage, air conditioning condensate, springs, water from crawl space pumps, pavement wash waters where spills or leaks of toxic or hazardous materials have not occurred (unless all spill material has been removed) and where detergents are not used, diverted stream flows, flows from riparian habitats and wetlands, uncontaminated water from foundations or from footing drains, lawn watering, dechlorinated swimming pool discharges, uncontaminated groundwater, water from individual residential car washing; and routine external building wash-down (which does not use detergents or other compounds).

In the event that the Township determines that any of these discharges significantly contribute pollutants to the Township's separate storm sewer system or to the Waters of the Commonwealth, or is notified of such significant contribution of pollution by PADEP, the Township will notify the responsible person to cease the discharge. Upon notice provided by the Township, the discharger shall, within a reasonable time period, as determined by the Municipality consistent with the degree of pollution caused by the discharge, cease the discharge.

Lastly, the Township also prohibits any private connections to the separate storm sewer system from indoor drains and sinks. Roof drain, sump pump, foundation and footing drain discharges, to the maximum extent practicable, shall discharge to infiltration or vegetative areas, or to other areas with adequate capacity to assist in the reduction of pollution prior to the runoff draining to our waterways. In the event you notice an illicit discharge to the Township's storm system and/or the waterways of the Township, please contact Jeffrey W. Please see Yard Waste Collection insert for more information on leaf bag collection. Rather than bagging your leaves, you need to only rake them to the front of your property immediately adjacent to the road's edge. LEAVES MUST BE AS CLOSE TO THE ROAD'S EDGE AS POSSIBLE.

PLEASE DO NOT RAKE LEAVES INTO THE STREET as leaves could get washed into storm inlets during inclement weather or can freeze to the roadway as we get cooler temperatures.

Thorndale Volunteer Fire Company

As we wind up our 2014 Annual Fund Drive on behalf of the Thorndale VOLUNTEER Fire Company I would like to thank our residents and businesses that continue to support our efforts! Without your support we could not survive and remember your donations are tax deductible. You may have seen our little fire boots on the counters at local businesses through out the township requesting your support. This is to supplement the annual fund drive and it has been doing well. Once again we thank you for your support! Just like things are getting tighter at your homethings are getting tighter at the firehouse and our VOLUNTEERS appreciate the support we receive from the community. The funds go towards the engine room utility bills, maintenance on the building and grounds, uniforms, equipment purchases that are not covered by funds from the State Fireman's Relief, equipment maintenance and fire prevention programs and literature.

I am pleased to provide the residents of Caln Township with the following update on the purchase of our new pumper:

On Friday, July 11, 2014, the Thorndale Volunteer Fire Company and Caln Township placed an order for a new pumper with 4-Guys Fire Trucks, Inc. of Meyersdale, PA through the local sales representative, Bob Pursel of Commonwealth Fire Equipment Company, Inc. located in Winchester, VA.

The new pumper is a 2015 Spartan Metro Star LFD with a stainless steel body manufactured by 4-Guys Fire Trucks, Inc. It will be powered by a Cummins ISL 450 HP engine with an Allison EVS 3000 transmission and includes a Hale QMAX 1500 GPM single stage pump, 750 gallon "L-Shaped" tank, 10 KW Onan hydraulic generator, and Will-Burt NightScan light tower. The "L-Shaped" tank allows hose lines to be accessible by Firefighters from the ground, without the need to climb up to pull the hose lines off.

The Spartan Metro Star LFD cab has several safety features including Spartan's Advanced Protection System, which includes a driver steering wheel airbag, driver dual knee air bags, officer knee air bags, full side curtain air bags, side impact protection, advanced seat belt system, integrated crash sensors, electronic stability control, and a reinforced cab structure. The roof configuration will be a flat roof, which allows the light tower to be mounted on the roof of the cab to free up storage space on the vehicle.

The fire suppression capabilities of the vehicle include 200' of 1-3/4" bumper attack line, (2) 200' 1-3/4" crosslay attack lines, (1) 200' 1-3/4" rear attack line, (1) 300' 1-3/4" rear attack line, (1) 200' 2-1/2" rear attack line, 150' of 1" booster line on a reel, and a TFT Crossfire monitor. The water supply to supplement the water tank will be established via a 5" rear intake with a Hale MIV-E valve. A 250' reel of 10/4 cable with junction block provides electric from the generator to portable lighting and fans. A Whelen LED warning light package with roto-ray, Federal Q2B, and Whelen electronic siren will provide audible and visual warning for the responding vehicle.

This vehicle comes at a cost of \$495,560.00 and has been entirely funded by Caln Township. Delivery is expected in June/July 2015. The new pumper will add to the current fleet of fire apparatus the company operates, which includes a 2003 Spartan/New Lexington Rescue Pumper and a 1995 HME/4-Guys Pumper.

Stay tuned to the fire company website for updates as the construction progresses.



A lot of people worked very hard to make this happen for the residences of our township, and I would like to thank the Board of Commissioners, Former Board Members Rose and Kramer, Township Manager Prowant, Assistant Township Manager Scheivert, Township Solicitor Camp and the Fire Company's Truck Committee for all their efforts.

Please remember we are here for you in your time of need 24 hours a day 365 days a year. We hope you never need our services but rest assured our VOLUNTEERS are always training so we are prepared for anything that may come our way.

REQUESTS FOR THE FALL 2014 CHIPPING PROGRAM CAN BE MADE STARTING FRIDAY, SEPTEMBER 5, 2014. APPOINTMENTS ARE REQUIRED. THE FIRST AVAILABLE APPOINTMENT FOR THE FALL 2014 CHIPPING PROGRAM IS TUESDAY, SEPTEMBER 16, 2014. THE PROGRAM WILL RUN WEEKLY TUESDAYS AND THURSDAYS THROUGH OCTOBER 30, 2014. APPOINTMENTS WILL BE TAKEN THROUGH FRIDAY, OCTOBER 10, 2014 OR UP UNTIL ALL APPOINTMENT SLOTS ARE TAKEN.

IN AN EFFORT TO ACCOMMODATE ALL REQUESTS FOR APPOINTMENTS, WE ASK THAT THE FOLLOWING GUIDELINES BE ADHERED TO:

- ALL BRANCHES AND LIMBS MUST BE STACKED AT THE FRONT OF THE PROPERTY NEXT TO THE STREET (WHERE TRASH CANS ARE PLACED FOR PICKUP).
NOTE: DUE TO LIABILITY CONCERNS, THE ROAD CREWS WILL NOT DRIVE ONTO PROPERTY OR PRIVATE LANES/ROADWAYS, NOR WILL ROAD CREWS GO BEYOND THE EDGE OF THE PROPERTY TO COLLECT THE LIMBS.
- ALL BRANCHES SHOULD FACE THE SAME DIRECTION (NO CROSS-STACKING) WITH THE BLUNT/CUT END FACING THE STREET
- NO STUMPS OR LIMBS GREATER THAN 8" IN DIAMETER, NO VINES, WEEDS, LEAVES, OR YARD WASTE WILL BE COLLECTED
- A RESIDENT MAY USE THIS FREE SERVICE ONE TIME DURING THE PROGRAM PERIOD

THE PROGRAM IS FOR ROUTINE CLEANUP AND NOT DESIGNED TO ASSIST WITH CLEARING PROPERTIES OF TREES AND SHRUBS (I.E. TREES CUT DOWN AND PUT OUT FOR CHIPPING WILL NOT BE COLLECTED).

THIS PROGRAM IS FOR INDIVIDUAL CALN TOWNSHIP RESIDENTIAL PROPERTIES ONLY. ITEMS COLLECTED FROM OUTSIDE THE TOWNSHIP OR THROUGH A PRIVATE OR COMMERCIAL OPERATION WILL NOT BE PROCESSED.
