ORDINANCE 2021-03**

**AN ORDINANCE OF CALN TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA AMENDING CHAPTER 149 OF THE CALN TOWNSHIP CODE, PART II GENERAL LEGISLATION/VEHICLE AND TRAFFIC, ARTICLE III PARKING REGULATIONS TO AMEND SECTION 149-25 TITLED “PARKING PROHIBITED AT ALL TIMES” BY ADDING ADDITIONAL STREETS AND LOCATIONS WHERE PARKING IS PROHIBITED.**

**BE IT ENACTED AND ORDAINED** by the Board of Commissioners of Caln Township as follows:

**SECTION 1.** Chapter 149 of the Caln Code titled, “Vehicles and Traffic”, Section §149-25, titled, “Parking prohibited at all times” shall be amended to add the following highway locations:

**§ 149-25. Parking prohibited at all times.**

A. No person shall park a vehicle at any time upon any of the highways or parts thereof described below:

GL Eggleston Boulevard	Both Sides	Entire Length
Stockley Lane	Both Sides	GL Eggleston Boulevard to Dead End
Westerham Road	Both Sides	GL Eggleston Boulevard to Honeymead Road
Honeymead Road	Both Sides	Entire Length
Fynamore Lane	Both Sides	Entire Length
Shelburne Road	Both Sides	Entire Length
Avebury Stone Circle	Both Sides	Entire Length
Ingleside Drive	Both Sides	Entire Length
Jason Lane	Both Sides	Entire Length
Harvest Drive	Both Sides	Entire Length
Courtney Lane	Both Sides	Entire Length
Lisa Drive	Both Sides	Entire Length

**SECTION 2. Severability.** If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts hereof. It is hereby declared as the intent of the Board of Commissioners that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

Ordinance 2021-03 Amending Chapter 149 of the Caln Township Code, Part II General Legislation/Vehicle and Traffic, Article III Parking Regulations to Amend Section 14-25 Titled "Parking Prohibited at all Times" by Adding Additional Streets and Locations Where Parking is Prohibited.

**SECTION 3. Repealer.** All ordinances or parts of ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

**SECTION 4. Effective Date.** This Ordinance shall become effective upon enactment as by law provided.
