

**CALN TOWNSHIP
CHESTER COUNTY, PENNSYLVANIA
ORDINANCE # 2021-07**

AN ORDINANCE OF CALN TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA AMENDING CHAPTER 149 OF THE CALN TOWNSHIP CODE, TITLED, "VEHICLES AND TRAFFIC" TO AMEND SECTION 149-11 TITLED "TURNS AT INTERSECTIONS" BY ADDING ADDITIONAL STREETS AND LOCATIONS WHERE TURNS AT INTERSECTIONS ARE PROHIBITED AND SECTION 149-25 TITLED "PARKING PROHIBITED AT ALL TIMES" BY ADDING ADDITIONAL STREETS AND LOCATIONS WHERE PARKING IS PROHIBITED.

BE IT ENACTED AND ORDAINED by the Board of Commissioners of Caln Township as follows:

SECTION 1. Chapter 149 of the Caln Code titled, "Vehicles and Traffic", Section §149-11, titled, "Turns at Intersections" shall be amended to add the following highway locations:

§ 149-11. Turns at intersections.

No person shall make a turn of the kind designated (left, right, all) at any of the intersections described below:

<u>Name of Highway</u>	<u>Direction of Travel</u>	<u>Prohibited Turn</u>	<u>at Intersection of</u>
Brooks	East	Left	Foundry

SECTION 2. Chapter 149 of the Caln Code titled, "Vehicles and Traffic", Section §149-25, titled, "Parking prohibited at all times" shall be amended to add the following highway locations:

§ 149-25. Parking prohibited at all times.

A. No person shall park a vehicle at any time upon any of the highways or parts thereof described below:

<u>Name of Highway</u>	<u>Side</u>	<u>Location</u>
Foundry	Odd Number House Addresses	Thirty (30) feet from the Northwest Corner of Brooks Lane

Ordinance 2021-07 Amending Chapter 149 of the Caln Township Code, titled "VEHICLES AND TRAFFIC" to amend Section 149-11 titled "TURNS AT INTERSECTIONS" by adding additional streets and locations where turns at intersections are prohibited and section 149-25 TITLED "PARKING PROHIBITED AT ALL TIMES" by adding additional streets and locations where parking is prohibited.

SECTION 3. Severability. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts hereof. It is hereby declared as the intent of the Board of Commissioners that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

SECTION 4. Repealer. All ordinances or parts of ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

SECTION 5. Effective Date. This Ordinance shall become effective upon enactment as by law provided.
