ORDINANCE 2021-02

AN ORDINANCE OF THE COMMISSIONERS OF CALN TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA AMENDING THE CODE OF ORDINANCES OF CALN TOWNSHIP SPECIFICALLY PART II GENERAL LEGISLATION, ARTICLE V SNOW AND ICE EMERGENCIES, CHAPTER 149 VEHICLES AND TRAFFIC, SECTION 149-40(B) AND VIOLATIONS SECTION 149.42(A)(B) PARKING PROHIBITED ON CERTAIN STREETS

WHEREAS, in order to facilitate the movement of traffic and to combat the hazards of snow and ice on the streets or portions of streets named, the Board of Commissioners, in its discretion, may declare an emergency due to such hazards, and

WHEREAS, the streets or portions thereof to which the provisions of this article shall be applicable during all periods of emergency declared as provided above, shall be added to Section §143-40 (B) of the list of Highways named in Parking Prohibited on Certain Streets.

The following Highways and Limits shall be added to the existing Ordinance 2020-01 and the Codified Ordinances of Caln Township §149-40(b):

| Name of Highway        | Limits   |

| <b>Foundry Street</b>  | <b>entire length</b>                             |
| <b>Brook Lane</b>      | <b>entire length</b>                             |
| <b>Courtney Lane</b>   | <b>Ingleside Drive to dead end</b>               |
| <b>Lisa Drive</b>      | <b>Ingleside Drive to dead end</b>               |
| <b>Ingleside Drive</b> | <b>North Bailey Road to GO Carlson Boulevard</b> |
| <b>Jewell Ave</b>      | <b>Hazelwood Avenue to dead end</b>              |

And,

WHEREAS, Ordinance 2020-01 shall also be amended to reflect the following language in §149-42, titled Violations in the Caln Township Codified Ordinances. The following section shall be added:

- A. Any person who shall park a motor vehicle or other motorized or recreational vehicle upon or along any of the streets or portions thereof listed in § **149-40B** at any time during a period of **emergency** declared as provided in § **149-39** shall be guilty of a

violation of this article and subject to the penalties in § 149-54 and/or §149-43 of this chapter.

- B. Any person who shall operate a vehicle or other motorized or recreational vehicle upon any streets or portion thereof listed in § 149-40B, which such vehicle or other motorized or recreational vehicle shall become stalled upon any of such streets during a period of emergency declared as provided in § 149-39 of this article, if such stalling shall have been by reason of the failure to have such vehicle or other motorized or recreational vehicle equipped with the equipment hereinabove prescribed, shall be guilty of a violation of this article and subject to the penalties in § 149-54 and or §149-43 of this chapter.

NOW THEREFORE BE IT ORDAINED, THAT THE COMMISSIONERS OF CALN TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA AMEND THE CODE OF ORDINANCES OF CALN TOWNSHIP SPECIFICALLY PART II GENERAL LEGISLATION, ARTICLE V SNOW AND ICE EMERGENCIES, CHAPTER 149 VEHICLES AND TRAFFIC, SECTION 149-40(B) AND VIOLATIONS, SECTION 149.42(A)(B) PARKING PROHIBITED ON CERTAIN STREETS.
