ORDINANCE NO. 2022-10

**AN ORDINANCE OF THE TOWNSHIP OF CALN, CHESTER
COUNTY, PENNSYLVANIA, AMENDING CHAPTER 134 OF
THE CALN CODE TITLED, "STREETS AND SIDEWALKS",
SECTION 134-35 TO AMEND THE LIGHTING
ASSESSMENTS FOR TOWNSHIP LIGHT DISTRICTS.**

BE, IT ENACTED AND ORDAINED by the Board of Commissioners of Caln Township as follows:

SECTION I. Chapter 134 of the Caln Code, titled, "Streets and Sidewalks", Section 134-35, titled, "Amount of Tax" is amended as follows:

§ 134-35. Amount of Assessment.

Effective January 1, 2023 there is hereby imposed, assessed and levied an annual assessment upon each and every property benefited hereunder and on the owners and occupiers thereof, jointly and severally, located within the following districts which is in proportion to the number of feet the same fronts on the street, highway or portion thereof to be lighted in the following districts for the year 2023 and for each subsequent year.

SECTION II. Severability. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such provisions, sentences, clauses, sections, or parts hereof. It is hereby declared as the intent of the Board of Commissioner that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

SECTION III. Repealer. All Ordinances or parts of Ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

SECTION IV. Renumbering. The location and numerical designation of these revised Sections shall be delegated to the discretion of the General Code Publishers, which may renumber or reorder these revised Sections as is necessary.

SECTION V. Effective Date. This Ordinance shall become effective immediately upon enactment as by law provided.
