**ORDINANCE 2023-02**

**AN ORDINANCE OF THE TOWNSHIP OF CALN, CHESTER COUNTY, PENNSYLVANIA, AMENDING CHAPTER 141 OF THE CALN CODE TITLED, "TAXATION" AT SECTION 141- 67 TITLED, "DISCOUNTS; PENALTIES" TO COMPLY WITH ACT 57 OF 2022.**

**BE IT ENACTED AND ORDAINED** by the Board of Commissioners of Caln Township as follows:

**SECTION I.** Chapter 141 of the Caln Code, titled, "Taxation", Section 141-67, titled, "Discounts; penalties" is amended to read as follows:

**"§ 141-67. Discount; penalties.**

All taxpayers subject to the payment of real estate taxes assessed by the Township shall be entitled to a discount of 2% from the amount of such tax upon making payment of the whole amount thereof within two months after the date of the tax notice. All taxpayers who shall fail to make payment of any such taxes charged against them for four months after the date of the tax notice shall be charged a penalty of 10%, which penalty shall be added to the taxes by the Tax Collector and collected by the Tax Collector. However, such penalty shall not be assessed by the Tax Collector if the taxpayer is eligible for a waiver pursuant to Act 57 of 2022 (P.L.701, No. 57) amending the Local Tax Collection Law, as may be further amended."

**SECTION II. Severability.** If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such provisions, sentences, clauses, sections, or parts hereof. It is hereby declared as the intent of the Board of Commissioners that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

**SECTION III. Repealer.** All Ordinances or parts of Ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

**SECTION IV. Effective Date.** This Ordinance shall become effective immediately upon enactment as by law provided.
