

CALN TOWNSHIP PLANNING COMMISSION MEETING May 24, 2022

A work session was held at 6:30 PM to discuss items on the meeting agenda.

The Planning Commission held their regularly scheduled meeting on Tuesday, May 24, 2022 in the Municipal Building at 253 Municipal Dr. and via Zoom as a virtual meeting. A public notice was published in the Daily Local News on December 28, 2021. Due to technical difficulties some people were able to log into the meeting via Zoom and some were not so the Zoom Room was restarted multiple times.

The agenda was posted on the Township website and at the Township building on May 18, 2022.

The meeting was called to order at 7:38 P.M. by Chairman, John Adam Thomas.

Howell & Associates. There was a brief discussion about the review letter comments and the applicant requested the Planning Commission make a Conditional Recommendation for Approval. Mr. Thomas made a motion to recommend the land development for approval contingent upon satisfying the consultant review letters prior to the review of the Board of Commissioners. The motion was moved by William Schew and seconded by Jim Benko. With no objections the motion carries 5-0.
