A RESOLUTION OF CALN TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA ACCEPTING THE PROPOSED MUNICIPAL SEPARATE STORM SEWER (MS4) PERMIT PLAN, WHICH CONTAINS A POLLUTION REDUCTION PLAN TO REDUCE SEDIMENT AND NUTRIENT POLLUTION OF THE WEST BRANCH OF BRANDYWINE CREEK

WHEREAS, Caln Township has under the advice of a professional engineering firm created a MS4 plan that includes Pollution Reduction Measures to be submitted to the Pennsylvania Department of Environmental Protection that meets the criteria listed for minimum control standards, and

WHEREAS, Caln Township made this plan available via its website, at the township building and at public meetings for any constituents of the community to be able to voice concerns or suggestions about this plan,

WHEREAS, the plan presented addressed the six elements of minimum control that is required by the Pennsylvania Department of Environment Protection. These elements include: Public Education & Outreach, Public Involvement & Participation, Illicit Discharge Detection & Elimination, Construction Site Run-Off Controls, Post-Construction Stormwater Management, Pollution Prevention & good housekeeping of municipal operations, and

WHEREAS, the Elected Officials of Caln Township find the elements of this plan to have merit and wish to cooperate with the Pennsylvania Department of Environmental Protection to maintain clean waterways and streams throughout the State.

NOW THEREFORE BE IT RESOLVED, THAT CALN TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA ACCEPTS THE PROPOSED MUNICIPAL SEPARATE STORM SEWER (MS4) PERMIT PLAN, WHICH CONTAINS A POLLUTION REDUCTION PLAN TO REDUCE SEDIMENT AND NUTRIENT POLLUTION OF THE WEST BRANCH OF BRANDYWINE CREEK
