A RESOLUTION OF CALN TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA AUTHORIZING THE POLICE CHIEF TO SIGN A MEMORANDUM OF UNDERSTANDING FOR POLICE SERVICES WITH CHESTER COUNTY INTERMEDIATE UNIT.

WHEREAS, CHESTER COUNTY INTERMEDIATE UNIT (CCIU) is located within Caln Township and certain properties that are owned and operated by CCIU are located within Caln Township's Municipal Borders, and

WHEREAS, CCIU does not have a school district police department that operates within the municipal boundaries of Caln Township, and

WHEREAS, a Memorandum of Understanding is entered into between the CCIU and the Local Law Enforcement Authority pursuant to 24 P.S. § 13-1301-A of the Public-School Code of 1949, and

WHEREAS, the purpose of this Inter-Agency Cooperation Agreement is to delineate the roles and responsibilities of the CCIU and Local Law Enforcement Authority as they relate to incidents that may occur on CCIU property or on its buses, and

WHEREAS, This Agreement shall not be construed to alter, modify or supersede the jurisdiction of the Law Enforcement Authority as established by the Municipal Police Jurisdiction Act, 42 Pa.C.S.A. 8951, et seq.

NOW THEREFORE BE IT RESOLVED, THAT CALN TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA AUTHORIZES THE POLICE CHIEF TO SIGN A MEMORANDUM OF UNDERSTANDING FOR POLICE SERVICES WITH THE CHESTER COUNTY INTERMEDIATE UNIT.
