RESOLUTION 2023-02

**A RESOLUTION OF THE TOWNSHIP OF CALN, CHESTER COUNTY, PER THE
PROVISIONS OF CHAPTER 87 OF THE CALN TOWNSHIP CODE, TITLED,
"GARBAGE, RUBBISH AND REFUSE", ARTICLE VIII, PARAGRAPH 87-17 A
ESTABLISHING THE ANNUAL TRASH AND RECYCLING FEES.**

WHEREAS, Chapter 87 of the Caln Township Code titled, "Garbage, Rubbish and Refuse", Article VIII, Paragraph 87-17.A provides for an annual trash collection fee; and

WHEREAS, said Article provides that the Board of Commissioners may amend or revise said fee from time to time by resolution; and

WHEREAS, the Board of Commissioners has duly advertised and approved a Resolution adopting the 2023 Caln Township budget; and

WHEREAS, said budget provides for a \$15.00 per month per container collection fee for the weekly collection and disposition of recyclable materials from businesses. The fee includes the distribution to the business of a sixty-five gallon recycling container. The fee is billed \$30.00 per bi-monthly billing period per container and shall be payable six times per year. Payment is due by the last day of the month in which the bill is issued. After that date, a 10% penalty will be assessed; and

WHEREAS, said budget provides for an annual residential trash collection fee in the amount of \$354.00 per year; and

WHEREAS, said fee is billed \$59.00 per billing period per residential dwelling unit and shall be payable six times per year on a bi-monthly basis. Payment is due by the last day of the month in which the bill is issued. After that date, a 10% penalty will be assessed;

NOW THEREFORE, BE IT HEREBY RESOLVED BY the Board of Commissioners of Caln Township, Chester County, Pennsylvania, that the annual residential trash collection fee for the year 2023 shall be \$354.00 and the collection fee for the weekly collection and disposition of recyclable materials from businesses shall be \$15 per month per container. Said fees shall continue each subsequent year until such time as the Board of Commissioners approves a resolution amending the fees.
